I, _____, hereafter referred to as the adopter², hereby agree that the above described animal is being adopted by me solely as a pet for myself and/or my immediate family. I agree that I will not sell, give away or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute or any other entity for any reason.

_____ I hereby agree to care for the above described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water, and veterinary care.

_____ I hereby agree to provided any necessary medical attention and annual vaccinations.

_____ I hereby agree that at any time during the entire life of the adopted pet that a home visit may be conducted by a representative of WWC to check the welfare of the pet. In the event it is discovered by either a WCC representative or by any other means that the adopted pet has been inhumanely treated, used for any illegal purpose or the adopter is in breach of this Contract including all its covenants and conditions, it is agreed WCC has the right to immediately take possession of said pet without notice to the adopter and rescind this Contract.

_____ I hereby agree that for the entire life of the adopted pet that I will not declaw the adopted pet.

_____ I hereby agree that the adoption fee of \$ _____ helps to cover WCC's expense of raising and caring for the animal and is not refundable after a trial period of 7 days.

_____ I hereby understand and agree that WCC makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that Wilson County Cats further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family.

RETURN POLICY

_____ If at any time adopter decides not to keep the pet the adopter hereby agrees to return them to WCC. The adopter agrees that any and all expenses incurred during the adopter's possession of the adopted pet will not be reimbursed by WCC. The adopter agrees to safely transport or provide transport of the adopted pet at their expense and return the adopted pet to WCC and the adopter will return any/all paperwork provided by WCC at that time.

_____ I certify that all statements made by me on this adoption agreement are true and correct. I agree that Wilson County Cats has the right to confiscate the above described animal in the event that any statements made by me are found to be false and/or my check for the adoption fee is returned for insufficient funds.
